**AUTHORIZING NEGOTIATION AND EXECUTION OF BLOOD PRODUCT SERVICES  
AGREEMENT WITH CENTRAL IOWA HOSPITAL CORPORATION D/B/A  
IOWA METHODIST MEDICAL CENTER**

**WHEREAS**, the City of Des Moines Fire Department (DMFD) desires to coordinate with Central Iowa Hospital Corporation doing business as (d/b/a) Iowa Methodist Medical Center ("UnityPoint") on a new program involving the supply of pre-hospital blood products to DMFD ground transport emergency management services (EMS) for treatment of injured patients; and

**WHEREAS**, UnityPoint has requested that the City of Des Moines enter into a Blood Product Services Agreement setting forth the roles and responsibilities of both parties, including an initial one-year term with automatic successive one-year renewal periods and program guidelines; and

**WHEREAS**, the Des Moines Fire Department wishes to negotiate and finalize the terms of said Agreement and implement said program with UnityPoint, as recommended by the Fire Chief.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that

1. The Des Moines Fire Department is hereby authorized and directed to proceed with negotiation of a Blood Product Services Agreement with Central Iowa Hospital Corporation doing business as (d/b/a) Iowa Methodist Medical Center.
2. The Fire Chief is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
3. Following approval as to form by the Legal Department and execution by the Fire Chief, the Fire Chief is further directed to administer said Agreement on behalf of the City, including consideration and approval of amendments subject to prior approval as to form by the Legal Department.
