RESOLUTION APPROVING PROCUREMENT OF DES MOINES FIRE DEPARTMENT RECORDS MANAGEMENT SERVICES, APPROVING USE OF NASPO VALUE POINT CONTRACT #AR2472 AND STATE OF IOWA PARTICIPATING ADDENDUM #2024-BUS-0226, AND AUTHORIZING NEGOTIATION AND EXECUTION OF SUPPLEMENTAL AGREEMENT

WHEREAS, the Des Moines Fire Department has requested the Finance Department, Procurement Division to procure Records Management Services (RMS) and related annual maintenance for a five-year period, licensing, implementation and training services ("initial RMS services"), and additional related services on an optional basis ("optional RMS services"); and

WHEREAS, the Procurement Administrator has determined that the requested initial RMS services and optional RMS services have been competitively bid and are available from Carahsoft Technology Corporation, 11493 Sunset Hills Road, Suite 100, Reston, Virginia 20190, through its reseller Locality Media, Inc. doing business as First Due, 107 7th Street, Garden City, NY 11530, using the NASPO ValuePoint Master Agreement #AR2472 cooperative purchasing contract and related State of Iowa Participating Addendum #2024-BUS-0226; and

WHEREAS, Des Moines Municipal Code Section 2-726(b)(20) provides for the procurement of goods or services from contracts that have been competitively established through cooperative group contracting consortiums for State government departments, institutions, agencies and political subdivisions, such as NASPO ValuePoint Master Agreement #AR2472, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the initial RMS services will be purchased in the total amount not to exceed \$290,974.73, and optional services may be purchased at the City's discretion in a total amount not to exceed \$1,121,083.99, subject to funding availability and determination of need by the Fire Department; and

WHEREAS, funding for said purchase is available from FD102000 (FD Technical Services) and FD105000 (FD EMS) 525195 (Software Licenses); and

WHEREAS, said procurement will require a Short Form Agreement between the City and Carahsoft Technology Corporation and/or Locality Media Inc. d/b/a First Due to supplement NASPO ValuePoint Master Agreement #AR2472 and State of Iowa Participating Addendum #2024-BUS-0226 with terms specific to the City's procurement, with said agreement to be negotiated by the City's Finance and Fire Departments.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that:

1. The purchase of Records Management Services (RMS) and related annual maintenance for a five-year period, licensing, implementation and training services, and additional related services on an optional basis, at a total amount not to exceed \$290,974.73 for the initial RMS services and a total amount not to exceed \$1,121,083.99 for the optional services, and per the general terms of NASPO ValuePoint Master Agreement #AR2472 with Carahsoft Technology Corporation and through its reseller Locality Media
