RESOLUTION APPROVING \$51,400.00 OF ADDITIONAL FUNDS FOR PROFESSIONAL SERVICES AGREEMENT WITH OLSSON, INC. FOR FIBER RELOCATION DESIGN FOR A TOTAL AMOUNT OF \$215,560.00

WHEREAS, the Information Technology Department has requested the Finance Department, Procurement Division to issue a purchase order for additional professional consulting services for the City Facility Expansion Argonne Armory Fiber Relocation Design Project; and

WHEREAS, by Roll Call #24-1274, dated September 16, 2024, the City Council approved the agreement for Professional Services for the City Facility Expansion Argonne Armory Fiber Relocation Design Project ("Project") with Olsson, Inc. (Brad Strittmatter President, 601 P Street, Suite 200, Lincoln, Nebraska 68508) ("Contractor") in an amount not to exceed \$164,160.00; and

WHEREAS, additional spending in the amount of \$51,400.00 is anticipated for the remainder of the Project for additional professional services from Contractor to incorporate an unforeseen change in design requirement; and

WHEREAS, the \$51,400.00 in additional funding is available from Capital Improvement Program (CIP) Fiscal Year (FY) 2024-2025, MS001, C051IT, Enhanced Information and Communication System, Page 26.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the additional expenditure of \$51,400.00, with a total not to exceed amount of \$215,560.00 for professional services pursuant to the above-described Professional Services Agreement between the City and Olsson, Inc., is hereby approved.
