HOLD HEARING FOR VACATION OF CB & Q STREET RIGHT-OF WAY BETWEEN SE 25TH COURT AND SE 30TH STREET AND CONVEYANCE TO THE DES MOINES METROPOLITAN WASTEWATER RECLAMATION AUTHORITY FOR THE WRA TREATMENT FACILITIY PLAN IMPROVEMENTS PROJECT

WHEREAS, On September 8, 2025, by Roll Call No. 25-1205, the City Council of the City of Des Moines, Iowa voted to receive and file a communication from the City Plan and Zoning Commission to vacate approximately 4.3 acres of the CB & Q Street right-of-way between SE 25th Court and SE 30th Street in the vicinity of 2901 CB & Q Street, to allow the vacated areas to be assembled for expansion of the wastewater reclamation authority facility (hereinafter "Property"), subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated at no cost to the City; and

WHEREAS, the Des Moines Metropolitan Wastewater Reclamation Authority (hereinafter "WRA"), owner of 2901 CB & Q Street, Des Moines, Iowa, has requested the City convey the Property in accordance with Iowa Code §364.7(3) to allow for assemblage with their adjoining property, subject to the reservation of any necessary easements for all existing utilities in place until such time that they are abandoned or relocated, and further subject to an ingress/egress easement to allow the City to maintain and operate a City-owned pump station, and further subject to an easement for railroad purposes over a portion of the property until such time that the railroad operation ceases and no longer exists or the railroad tracks are removed; and

WHEREAS, there is no known current or future public need for the Property proposed to be vacated and conveyed, and the City will not be inconvenienced by the vacation and conveyance of said Property; and

WHEREAS, on September 29, 2025 by Roll Call No. <u>25-/285</u> it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed conveyance be set down for hearing on October 20, 2025, at 5:00 p.m., in the City Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa; and

WHEREAS, due notice of said proposal to vacate and convey the Property was given to all necessary parties as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with City Council direction, those interested in the proposed vacation and conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. Upon due consideration of the facts and statements of interested persons, any and all objections to the proposed vacation and conveyance of street right-of-way, as described herein, are hereby overruled and the hearing is closed.
