**FORGIVENESS AND RELEASE OF COMMUNITY DEVELOPMENT BLOCK GRANT  
– DISASTER RECOVERY (CDBG-DR) PROGRAM RECORDED DOCUMENTS  
AGAINST 350 E LOCUST STREET**

**WHEREAS**, by Roll Call 13-1476 on September 13, 2013, the City entered into a Community Development Block Grant – Disaster Recovery (CDBG-DR) Agreement, number 13-DR-900-00045 with East Village Growth Partners LLC for use of CDBG-DR Program funds (the “Agreement”); and

**WHEREAS**, in the Agreement, \$3,000,000 in CDBG-DR funds contributed to the new construction of 20 dwelling units at 350 E Locust St and secured affordability of four (4) efficiency units, four (4) one-bedroom units, and three (3) two-bedroom units for occupancy by households earning at or below 80% of the Area Median Income (AMI); and

**WHEREAS**, the period of affordability was ten (10) years from the time of project completion; and

**WHEREAS**, the Agreement between the City and East Village Growth Partners LLC did not require repayment of the CDBG-DR funding if all affordability and long-term monitoring conditions were fulfilled; and

**WHEREAS**, the period of affordability has ended and East Village Growth Partners LLC has fulfilled all long-term monitoring conditions as required by the Agreement; and

**WHEREAS**, East Village Growth Partners LLC has requested the release of the CDBG-DR liens after the end of the Period of Affordability pursuant to the Agreement; and

**WHEREAS**, releases for the CDBG-DR Program recorded documents will be prepared by Neighborhood Services.

**NOW, THEREFORE BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The Satisfaction and Discharge, whereby the City will release its Agreement, Restrictive Covenant, Mortgage, and Promissory Note on 350 E Locust St, is hereby approved.
2. The Satisfaction and Discharge, whereby the City will release its CDBG-DR Funded Restrictive Covenant with First American Bank, Senior Security, on 350 E Locust St, is hereby approved.
