WHEREAS, on October 24, 2022 under Roll Call No. 22-1613, the City Council approved a private construction contract in the amount of \$391,324.50, between Legacy Excavation, L.L.C., John W. Larson, Owner, 5721 Merle Hay Road, Suite 18, Johnston, IA, 50131 as Contractor, and J. Larson Homes, L.L.C., John Larson, President, 5721 Merle Hay Road, Suite 18, Johnston, IA, 50131 as Owner, for construction of Storm Sewer Improvements to serve Three Lakes Estates Plat 10, located northeast of the intersection of Lake Hill Drive and Brockway Drive, as shown on Plan File numbers 630-125/154, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.
