APPROVING DE MINIMIS IMPACT FINDING FOR CONSTRUCTION REQUIRING TEMPORARY CLOSURE OF THE CARL VOSS AND JOHN PAT DORRIAN TRAILS AND PERMANENT EASEMENT IN PETE CRIVARO PARK AND AUTHORIZING EXECUTION OF FORMS WITH IOWA DEPARTMENT OF TRANSPORTATION

WHEREAS, the City of Des Moines is the owner of the Carl Voss Trail, John Pat Dorrian Trail, and Pete Crivaro Park; and

WHEREAS, the Iowa Department of Transportation (IDOT) intends to undertake construction that will impact the Carl Voss Trail, John Pat Dorrian Trail, and Pete Crivaro Park; and

WHEREAS, in compliance with federal law that protects significant publicly owned parks and recreational areas, IDOT has worked with the City of Des Moines Engineering Department and Parks and Recreation Department to limit the impact of the future construction project on City-owned parks and trails; and

WHEREAS, the Parks and Recreation Department Director has determined the construction will have a de minimis impact on the Carl Voss Trail, John Pat Dorrian Trail, and Pete Crivaro Park.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that:

- 1. The Section 4(f) de minimis impact findings for the Carl Voss Trail, John Pat Dorrian Trail, and Pete Crivaro Park, as contained in forms on file in the City Clerk's Office, are hereby approved; the Parks and Recreation Department Director is authorized and directed to execute each form on behalf of the City.
2. The Parks and Recreation Department Director is authorized to consider, approve, and execute future Section 4(f) de minimis impact forms, following approval as to form by the Legal Department.
