**RESOLUTION APPROVING \$137,000 OF ADDITIONAL FUNDS FOR
THE PURCHASE OF PHONE SYSTEM IMPLEMENTATION CONSULTING
AND PROFESSIONAL SERVICES FROM CARRIER ACCESS INFORMATION
TECHNOLOGY PURSUANT TO CITY OF DES MOINES CONTRACT
#K25-336, FOR A TOTAL ESTIMATED AMOUNT OF \$422,000**

WHEREAS, the Information Technology Department previously requested the Finance Department's Procurement Division to issue a purchase order for the purchase of implementation consulting and professional services; and

WHEREAS, on June 9, 2025, by Roll Call No. 25-0848, the City Council approved the purchase of implementation consulting and professional services from Carrier Access Information Technology, an authorized subcontractor of TD Synnex Corporation, in an amount not to exceed \$285,000.00, per the general terms and pricing of Omnia Partners Contract #R200803 and approved Short Form Agreement #K25-336 between the City and TD Synnex Corporation supplementing Omnia Contract #R200803; and

WHEREAS, additional spending on implementation consulting and professional services in the amount of \$137,000.00 is anticipated due to additional work, tasks, support and training identified during the phone system rollout; and

WHEREAS, the additional funding for the implementation consulting and professional services is available from Capital Improvement Program (CIP) Fiscal Year (FY) 2026, MS001, C051IT99, Miscellaneous Improvements Enhanced City-wide Information and Communication Systems, Page 57.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the additional expenditure of \$137,000.00, with a total estimated amount of \$422,000.00, for implementation consulting and professional services to be procured from Carrier Access Information Technology, an authorized subcontractor of TD Synnex Corporation, pursuant to Short Form Agreement #K25-336 between the City and TD Synnex Corporation supplementing Omnia Contract #R200803, is hereby approved.
