REPROGRAMMING OF PRIOR YEARS' UNSPENT COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS

WHEREAS, on November 3, 2025, by Roll Call No. 25-1505, the City Council held a public hearing regarding the proposed 2025-2029 Consolidated Plan, which outlines the City's five-year strategy for use of its entitlement funds such as Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME) Program, and Emergency Solutions Grant (ESG) from the U.S. Department of Housing and Urban Development (HUD), and authorized the City Manager to submit the 2025-2029 Consolidated Plan to HUD; and

WHEREAS, on November 3, 2025, by Roll Call No. 25-1505, the City Council held a public hearing regarding the proposed 2026 Annual Action Plan, as part of the 2025-2029 Consolidated Plan, and authorized and directed the City Manager to submit the 2026 Action Plan with the required SF-424 application forms and required certifications to HUD once the 2026 allocations were known; and

WHEREAS, the City Manager has reviewed unspent prior year CDBG funding and is recommending that these funds be utilized as set out in the attached council communication and simultaneously administered with the Annual Action Plan activities; and

NOW, THEREFORE, BE IT RESOLVED, by the City Council of Des Moines, Iowa, that the City Manager's recommendations regarding the utilization of unspent prior years CDBG funding as set out in Council Communication No. 26-160 are hereby approved.
