RESOLUTION APPROVING THE PURCHASE OF HEAVY DUTY CHASSIS UPFITTING FROM TRUCK EQUIPMENT, INC. AND HAWKEYE TRUCK EQUIPMENT PURSUANT TO CITY OF DES MOINES CONTRACTS #K24-829 AND #K24-828 IN A TOTAL AMOUNT OF \$510,000

WHEREAS, the Fleet Division has requested the Finance Department’s Procurement Division to issue a purchase order for the purchase of heavy-duty chassis upfitting for fiscal year 2026; and

WHEREAS, the Procurement Administrator has determined that the requested heavy duty chassis upfitting has been competitively bid and is available from Truck Equipment Company, Inc. (1560 NE 44th Avenue, Des Moines, IA 50313, Terry Wieseler, Owner) using the State of Iowa DAS Master Agreement #21434 between Truck Equipment, Inc. and the State of Iowa, and from Hawkeye Truck Equipment (5800 NW 2nd St, Des Moines, IA 50313, Logan Steinkamp, Owner) using the State of Iowa DAS Master Agreement #25051 between Hawkeye Truck Equipment Company and the State of Iowa (collectively “DAS Agreements”), and further using existing City of Des Moines Contracts #K24-828 and K24-829 with said vendors; and

WHEREAS, Des Moines Municipal Code Section 2-726(2)(b)(18) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the FY2026 funding for the heavy duty chassis upfitting is available in the total amount of \$510,000.00 from the Fiscal Year (FY) 2026-2027 Recommended Operating Budget, Page 77, Equipment Replacement Fund.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the purchase of heavy duty chassis upfitting from Truck Equipment, Inc. and Hawkeye Truck Equipment Company in the total amount of \$510,000.00, pursuant to the pricing of the DAS Agreements and the terms of City of Des Moines Contracts #K24-828 and #K24-829, is hereby approved.
