APPROVING THE PURCHASE OF FIBER RELOCATION SERVICES FROM CONFLUENCE TECHNOLOGY GROUP, USING STATE OF IOWA AGREEMENT #20450 AND CITY OF DES MOINES SHORT FORM #K23-016, IN AN AMOUNT NOT TO EXCEED \$186,197

WHEREAS, the Information Technology Department has requested the Finance Department's Procurement Division to issue a purchase order for the purchase of fiber relocation services; and

WHEREAS, the Procurement Administrator has determined that the requested fiber relocation services are available from Confluence Technology Group (formerly known as Commonwealth Electric Company of the Midwest; Roger Hamilton, President, 3910 South Street, Lincoln, NE 68506) using State of Iowa Master Agreement #20450 ("State Contract"), and City of Des Moines Short Form Agreement #K23-016; and

WHEREAS, Des Moines Municipal Code Section 2-726(b)(18) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the fiber relocation services are being purchased from Confluence Technology Group, in an amount not to exceed \$186,197.00 utilizing the above-referenced State Contract and City of Des Moines Short Form Agreement; and

WHEREAS, funding for said purchase is available from Recommended Capital Improvement Plan (CIP) Fiscal Year (FY) 2027, BL-133, City Facility and Armory Replacement Project, Page 30.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. The purchase of fiber relocation services, in an amount not to exceed \$186,197.00, from Confluence Technology Group (formerly known as Commonwealth Electric Company of the Midwest), and pursuant to the general terms and pricing of State of Iowa Master Agreement #20450 and City of Des Moines Short Form Agreement #K23-016, is hereby approved.
2. The Information Technology Department Director is hereby authorized to approve and to sign any implementing or license agreements with Confluence Technology Group, subject to approval as to form by the Legal Department.
